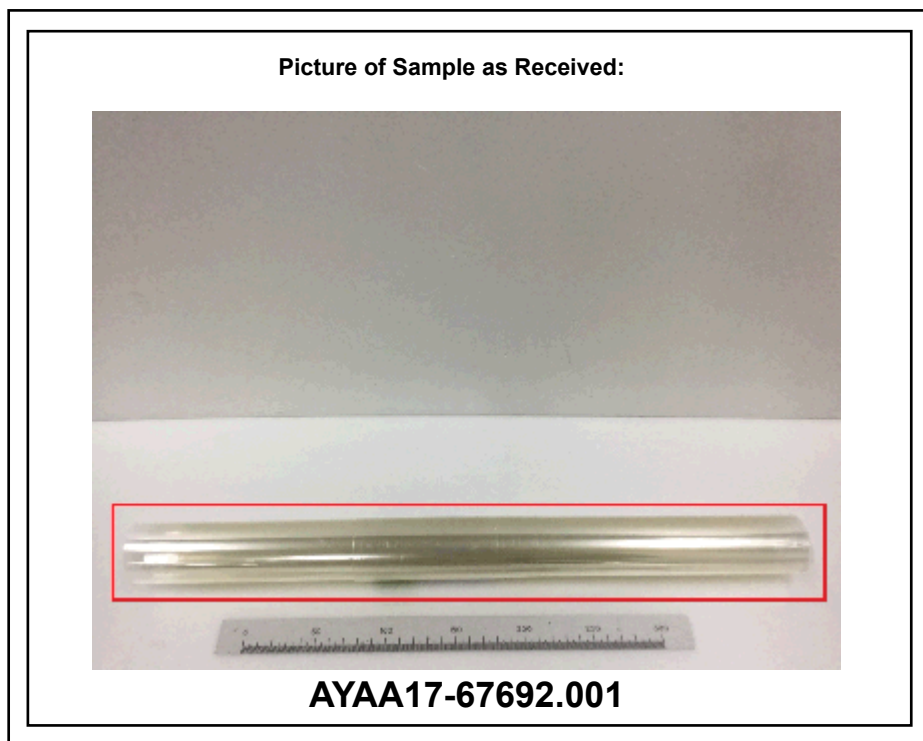

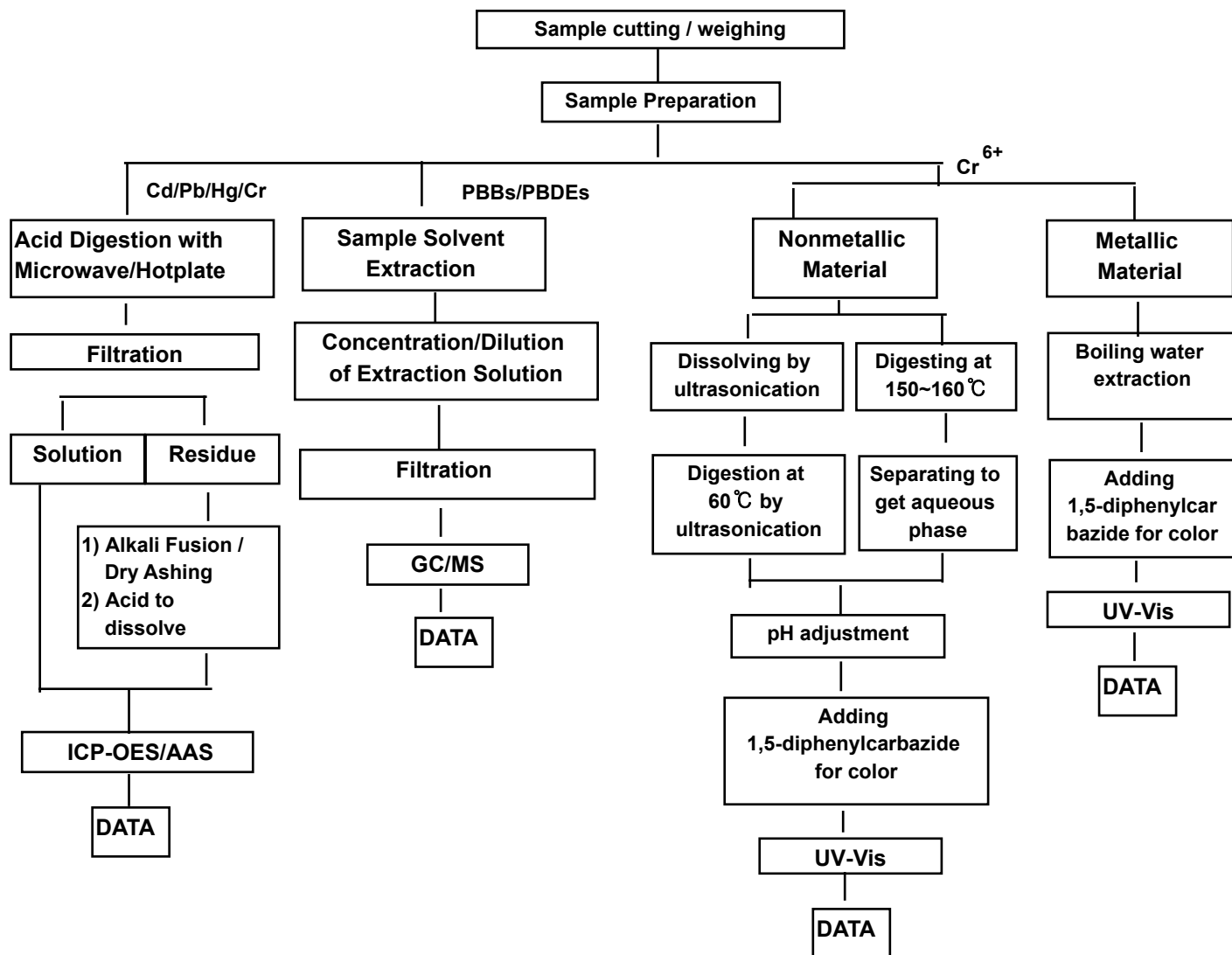

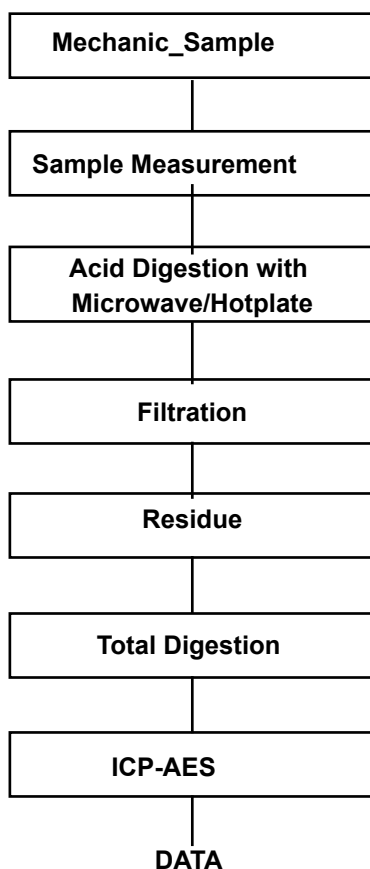
**Testing Flow Chart for RoHS:Cd/Pb/Hg/Cr<sup>6+</sup> /PBBs&PBDEs Testing**

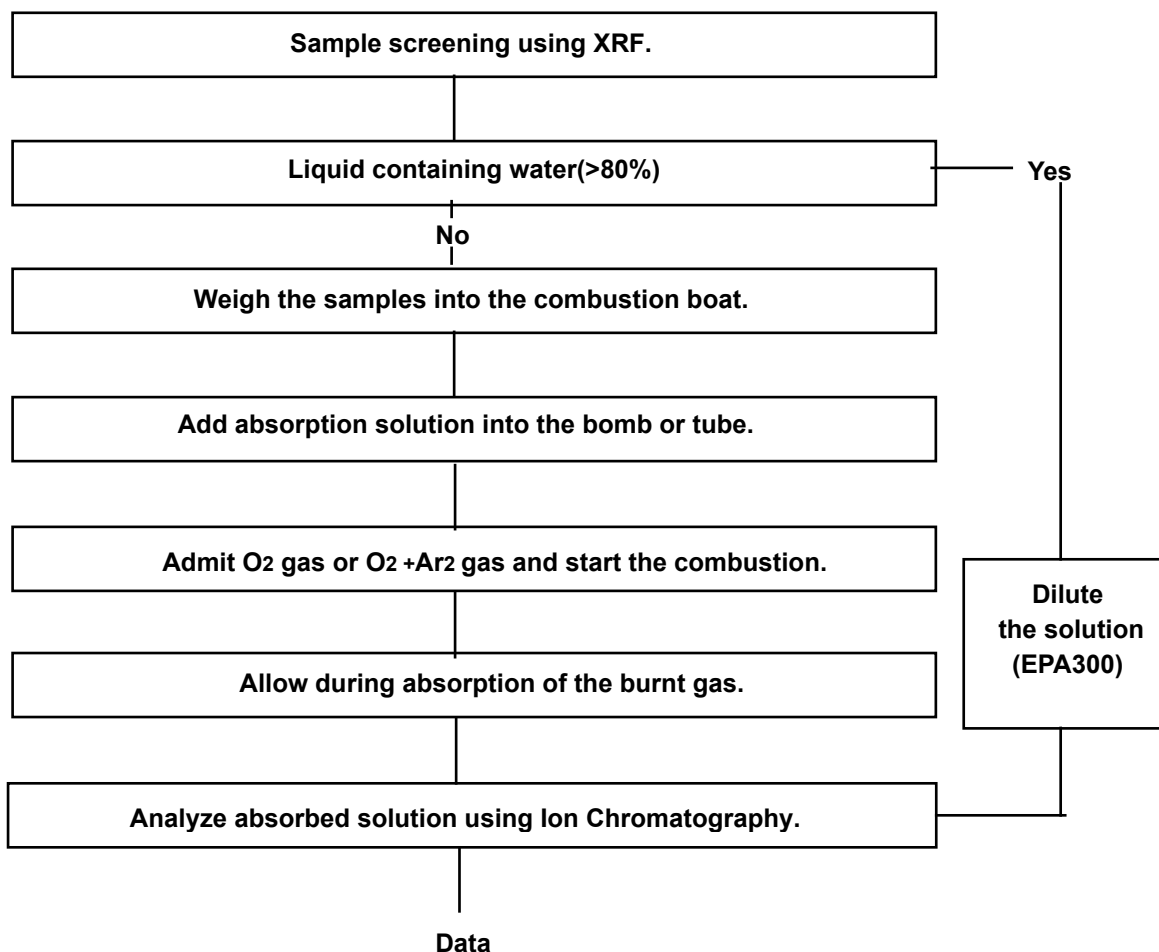

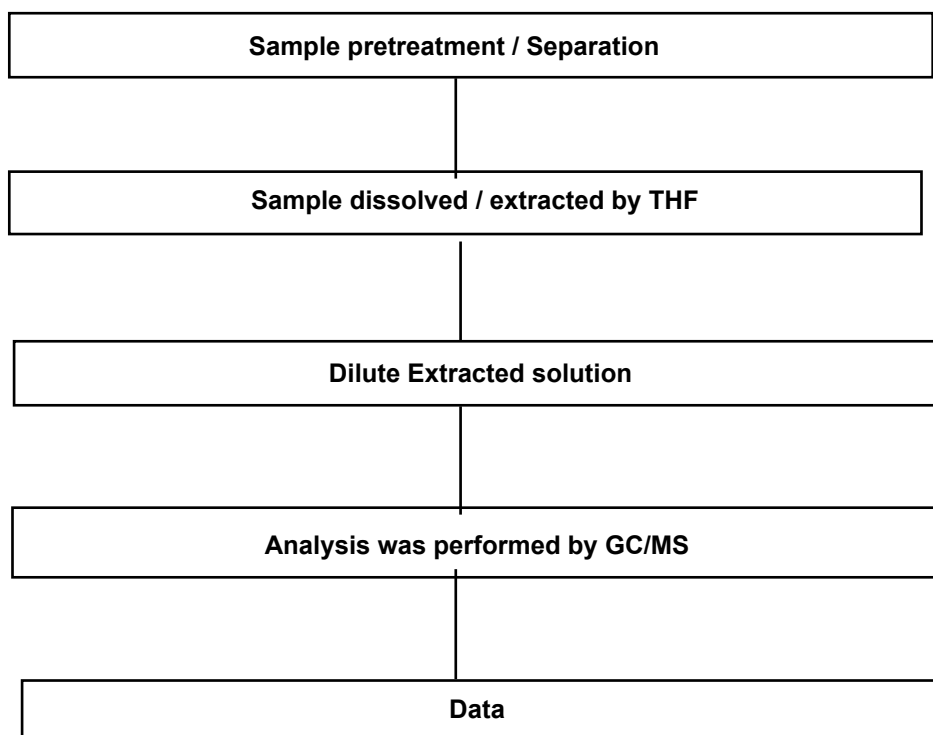
### Flow Chart for Halogen Test
